

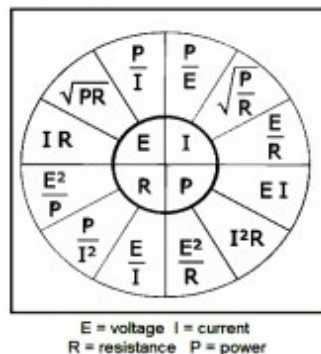

Minutes of the Coconino Amateur Radio Club

7/12/2018

At 6:45 pm Ron Gerlak presented a short program on J-Pole antennas, showing examples and offering wire to anyone that wanted to make their own. He further offered a soldering session at the next meeting if anyone needed help with that.

Following Ron's demonstration Dan Shearer initiated the After-Action Review [AAR] of Field Day. There was much discussion on the bullet points below:

Good Feedback:

Food

3A Stations/GOTA/6m

Lots of points

Vertical and Digital interference issues identified and resolved

Mark Christian helped in calling dignitaries during the event, most of those he spoke with attended

Safety efforts in place – nobody got hurt- fire extinguishers and water in place

Hand-held radios worked great for comms

Needs Improvement:

PIO List

GOTA Station – not everyone got to get on the air

Too competitive

Cleanup – not enough people to help with take down of equipment/antennas etc

Designated Hosts/Hostesses (besides the PIO) to escort dignitaries

“People who bring their own equipment should not complain about having to take it down”

Designated person for each station needs to make sure enough equipment is available to run the station

We were too busy to make time for guests

Mike Moroney working the SSB station noted that the SSB station had extra headphones set up so that visitors could listen in and then operate if desired.

Joe Hobart suggested that the Field Day GOTA rules requiring multiple contacts by an individual are not reasonable and suggested that we ignore that rule in order to get people on the air who are waiting.

We need a better head count on food – we were over \$100 short – we should at least break even.

Meeting Started: 7:10 pm

Secretary's Report: Since the minutes of the June meeting were published in the newsletter, there was no need to read them. Bill Smith made a motion to accept the minutes and Scott Martin seconded the motion. The minutes were approved unanimously.

Treasurer's Report: Pat Traber, our CARC Treasurer, reported that the closing bank balance is \$3,007.05. Membership is 58 members, consisting of 54 paid members and 4 lifetime members. Joe Hobart moved to accept the Treasurer's Report and Scott Martin seconded the motion. The report was approved unanimously.

President's Report: Dan Shearer, our CARC President, opened the business meeting with an introduction of all members. Dan did not have an additional report and turned the meeting over to Joe for an update on the HOPI Point Repeater.

Old Business:

HOPI Point Repeater: Due to the ongoing issues the ARA is to re-evaluate and has instructed CARC to "sit tight". Dan asked if county funding was a possibility. Currently, we want to leave this issue in the hands of ARA.

WINLINK - WINMORE: Per Ken Held, training is ongoing.

Code Class: There is not enough interest to hold a class.

CARC Trailer: The old trailer needs cleaning out. This is scheduled to be done on Saturday at Silver Saddle starting at 14:00. Once empty, a FOR SALE SIGN will be put on the trailer and it will be parked near the road. Dan will use his cell phone number to take calls from interested parties. Dan will also advertise on the Shasta Yahoo site. Bill Smith has offered to store bins of content removed from the OLD trailer at his locked shed. Bill also offered to keep the NEW trailer on his property.

50/50 Raffle: Betty Gerlak won the 50/50 raffle.

New Business: Election Reminder

Dan does not want to run for re-election. He will continue as PIO.

Janice Enloe does not want to run for re-election. She will continue to publish the newsletter.

Bill Smith was nominated for President. He accepted the nomination.

Phil Brunner was nominated for Vice President. He accepted the nomination.

There was some discussion regarding whether Erv Perelstein will continue as Secretary. If Erv is willing to continue, he has the club support and no voting will be necessary. If Erv is unable to continue, Bobbie Brunner has been nominated as Secretary.

Pat Traber will continue as Treasurer – thanks to Pat.

Other nominations will be accepted between now and the August meeting. Make sure your nominee will accept nomination. Contact any officer with your nominations.

Voting at the meeting will be by ballot.

Scott Martin reported the following:
